## License Transfer Instructions

If the computer on which Corporate Announcements is installed suddenly crashes or becomes inoperable and there is no way to recover the system to deactivate your license, you will need to request a license transfer using the SEC website ([www.sec.kmbs.us](http://www.sec.kmbs.us)). Follow these steps:

1. Log into the SEC website and select the **Assistance** tab.
2. On the Assistance window, select the **click here** link under **License Issues** to begin.
3. The SEC Policy screen will appear next; select the **Continue** link to affirm that you've read, understood, and agreed with SEC licensing policy.
4. A screen will appear, listing what you need in order to request a license transfer; select the **Next** button when you are ready.
5. The License Issue Submitter screen will appear. Select either **End User/Customer** or **Authorized Reseller**; then select the **Next** button. See the following illustration for an example of this screen:

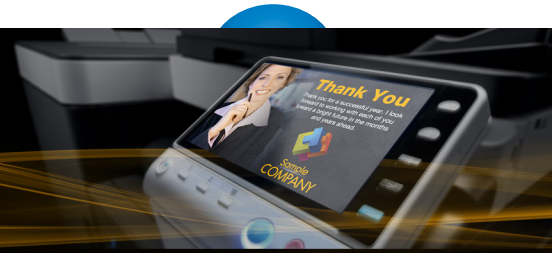

### Activating Registration On New Computer

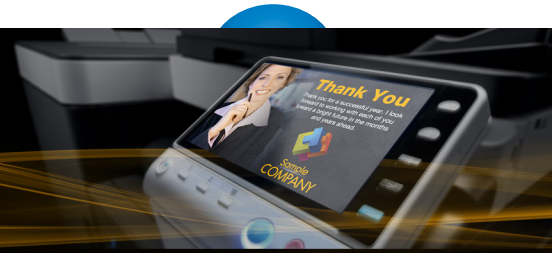
Once you receive your license transfer information, you can register Corporate Announcements on your new computer. Do the following:

1. Install the software on the new computer. When you start your new installation of Corporate Announcements, the Register screen will appear; then, do the following:
  - a. Select the **Full Version** radio button; then select **Next**.
  - b. On the next screen that appears, select the **Manual Registration** radio button, as in the following illustration:

3. Log into the SEC website ([www.sec.kmbs.us](http://www.sec.kmbs.us)); then click on the **Register** tab.
4. Select the **Click here to register your license transfer** radio button. Different fields on the bottom of the screen will appear, as in the following illustration:

5. Enter/paste the Purchase Code that was sent to you via email into the **Purchase Code** field. The product associated with that Purchase Code will automatically appear in the **Select Product** drop-down list.
6. Enter/paste the original unlock code from your old system in the **Deactivated Unlock Code** field.
7. Enter/paste the Lock Code from your new computer in the **Lock Code** field.
8. Select the **Submit** button when you are done.

This will generate the license file which corresponds to your application. A link to this file will be displayed. Click the link to download your license file.

9. Go back to the Corporate Announcements Register window. Select the **Browse** button to find the downloaded license file, and select the **Activate** button. Do NOT unzip the license file prior to activation.
