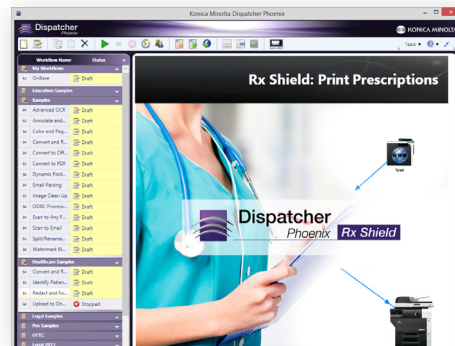

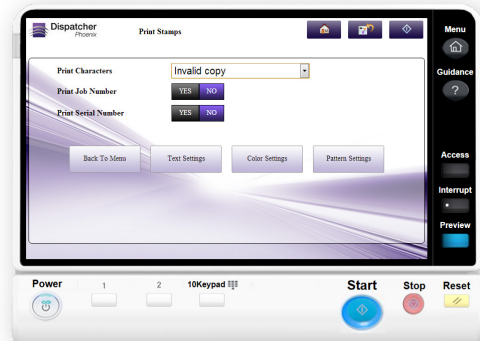

The prescription contains the following security features: 1) A background pantograph to prevent erasure and/or text modifications. 2) Warning text (Invalid Copy, etc.) that appears when the prescription is copied. 3) Warning box listing the security features that are present on the document.



**Comparison.**

Comparison of an original prescription protected by Rx Shield vs. the same prescription copied. Note that the lightly patterned background pantograph reveals warning text when the prescription is illegally copied.

**Copy Protection Features.**

A prescription protected by Rx Shield has a background pantograph that prevents erasures or text modifications, customized warning stamps, and a Security Features Warning Box that is added to the bottom of each prescription, alerting pharmacists to the security features present on the page.
